## Jesus on Forgiveness

*"I owe I owe so off to work I go"*



"Therefore, the kingdom of heaven is like a king who wanted to settle accounts with his servants. {24} As he began the settlement, a man who owed him ten thousand talents was brought to him. {25} Since he was not able to pay, the master ordered that he and his wife and his children and all that he had be sold to repay the debt. (The debt in modern terms = \$750,000,000)

Who is the king?

Who is the servant?

What's the debt?

*Pweeeeeese give me time to pay !!!*

"The servant fell on his knees before him. 'Be patient with me,' he begged, 'and I will pay back everything.' {27} The servant's master took pity on him, canceled the debt and let him go. {28}

Can you see anything wrong with what the servant asked?

What is the point of the king's letting him off completely—why did he do that? What is Jesus saying here?

*Can you believe this?????!!!*

"But when that servant went out, he found one of his fellow servants who owed him a hundred denarii. He grabbed him and began to choke him. 'Pay back what you owe me!' he demanded. {29} "His fellow servant fell to his knees and begged him, 'Be patient with me, and I will pay you back.' {30} "But he refused. Instead, he went off and had the man thrown into prison until he could pay the debt. (100 denarii = \$100.00)

Why was the forgiven servant in such a miserable mood after having had the debt cancelled?



How does this relate to the two things we need to be able to forgive?

Is it possible that he saw his friend's debt to him as a significant factor in putting him into debt to the king?

*Into prison till you learn your lesson!*

When the other servants saw what had happened, they were greatly distressed and went and told their master everything that had happened. {32} "Then the master called the servant in. 'You wicked servant,' he said, 'I canceled all that debt of yours because you begged me to. {33} Shouldn't you have had mercy on your fellow servant just as I had on you?' {34} In anger his master turned him over to the jailers to be tortured, until he should pay back all he owed. {35} "This is how my heavenly Father will treat each of you unless you forgive your brother from your heart." (Mat 18:23-35)
